OSHA 10 General Industry is designed to familiarize workers with OSHA Standards as well as safety and health hazards common to the workplace. This training is designed to be interactive with a goal to educate workers on identifying, avoiding, controlling, and preventing job site hazards.

**Topics (12) to be covered:** Introduction to OSHA; Electrical Hazards; Walking and Working Surfaces (Slips, Trips and Fall Hazard Protection); Personal Protective Equipment; Confined Space Awareness; Hazardous Chemical Safety Awareness; Blood Borne Pathogens; Exit Routes, Emergency Action Plans, Fire Prevention Plans and Fire Protection; Materials Handling, Storage & Use; Lock Out/Tag Out; Machine Guarding; and Fixed and Portable Ladder Safety.
